

Privacy and cookie statement

Privacy-sensitive data, i.e. personal data, are processed through the websites www.hostnet.nl and academy.hostnet.nl, owned by Hostnet bv. Hostnet respects your privacy and treats your personal data with due care and confidentiality. Your personal data are processed in accordance with the General Data Protection Regulation (GDPR).

In this privacy and cookie statement, we explain which personal data we collect and use, and for what purpose. We recommend that you read this statement carefully.

Use of your data

When using our website and services, you provide us with certain data, which may include personal data. For instance, we request some of your personal data when you place and pay for your order. In addition, you may provide us with personal data if you post a response on academy.hostnet.nl.

The website also offers the option to ask questions by means of a contact form, on which you are asked to fill in various data to enable us to answer your question. Lastly, you can register for a newsletter or for events.

Depending in part on the actions you carry out on our website, we may process the following data:

- Name and address details
- Email address
- Telephone number
- IP address
- Payment details
- Purchase history
- Login details

We use the aforementioned data to:

- enable you to use our services;
- enable you to purchase services through the website and use the functionalities of the website;
- grant you access to your account;
- IP address
- handle your order and provide information on its progress;
- send personalised newsletters on the basis of your interests and your purchase history;
- respond to questions that have been asked through the website;
- provide information on disruptions and maintenance of our services;
- improve our services.

Retention periods

The aforementioned data are retained for as long as necessary to provide our service to you and/or you are registered for our newsletter.

Newsletter

If you have given us permission for this, we can contact you by email and send you our newsletter. All communications sent by email include a link to unsubscribe.

Logging in via third parties

Hostnet offers the option of logging in to its websites by using your account with a third party (for instance, Facebook or Google). Hostnet is not responsible for the services of these parties. For information on the processing of data in connection with this method of logging in, please see the privacy policy of the party concerned.

Security

We take appropriate security measures to prevent the misuse of and unauthorised access to your personal data.

Disclosure of data to third parties

Hostnet does not disclose your data to third parties, except if required to do so under the law or if this is necessary to supply a product or service.

For the registration of domain names, your personal data are transferred to the issuing authority and any registrars (intermediate parties) that Hostnet uses as a supplier. Those parties and Hostnet may make back-ups of your domain name data for gTLD domain names* and transfer them to the care of a third party. In addition, your domain name data are made publicly visible on the WHOIS server of the issuing authority.

*gTLD refers to domain names of the type generic, generic-restricted or sponsored, as stated by IANA.

Mandatory domain name data

Unless they are designated as optional, the data that Hostnet asks you for are required in order for it to provide you with a domain name. The domain name terms and conditions provide more information on the privacy policy of the registration authorities.

Modification of your data

You can access and modify your customer data through Mijn Hostnet. After logging in, go to 'Account'. This is where you can find and change your contact details.

You can also modify your domain name data through Mijn Hostnet. After logging in, go to 'Support' > 'Contact'. Next, follow the indicated steps.

Your rights

If you have provided personal data to us, you can send us a request to access, amend or remove those data. In addition, you have the right in some cases to restrict the processing of your personal data, to object to it or to export your data.
